MEMORANDUM OF UNDERSTANDING

Where as **Shri Bhagwan Homoeopathic Medical College & Indira Gandhi Memorial Hospital** is running in Aurangabad (hereafter called as Party No.1) which is affiliated to Maharashtra University of Health Sciences, Nashik for 1) B.H.M.S. (U.G.) and 2) M. D. (Homoeopathy) (P.G.) Courses and recognized by Central Council of Homoeopathy, New Delhi.

And whereas Party No.1 has been functioning in the area of Homoeopathic Medical Education is running Homoeopathic College & Homoeopathic Hospital in Aurangabad with a number of Senior and Experienced Consultants in Homoeopathy.

And where as **YSK Hospital (Multi & Super Speciality), Aurangabad** a subsidiary of **Bhagwan Shikshan Prasrak Mandal** (Hereafter called as a Party No.2) has a capacity of **250 beds** and registered under Bombay Nursing Home Act having following ultra modern medical facilities.

- 1) Radiology with two X-Ray Machine of 300 & 700 MA, one U.S.G. Machines with 3D Sector-Scan Portable, C.T. Scan 500 slice with a capability to do Cardiac studies.
- 2) Pathology Lab. with capability to diagnose assess all types of parameters in human body, Histopath, Microbiology & Serological studies.
- 3) Day Care, Emergency, Casualty for 24 hrs.
- 4) Class 100 Operation Theaters, Transplant Operation Theater, Cath. Lab & Cardiac Theaters (proposed).
- 5) Dialysis Unit – haemo. & abdominal (proposed).
- 6) ICU – 40 beds (proposed) ICCU – 5 beds, PICU – 5 beds.
- 7) Endoscopy Unit for Upper & Lower G.I. & Gynaec., ENT and Pulmonary diseases with Laparoscopic Surgeries.
- 8) All Operation Theaters have Audio-Visual communication facilities with the Seminar Halls and also wireless 2 way communication through Internet to remote places sensing and transmission reception.


Party No.1 & Party No.2 for the wider motif of mutual benefit and the Students of the Institution a desire to spread and propogate the Science of Homoeopathy amongst all section and levels of Society, have agreed to sign this Memorandum of Understanding (MoU) with following objectives, terms and conditions :

1. This MoU is being signed as part – fulfillment of clinical facility for Students.
2. The MoU will be valid for period of Five years commencing **01/04/2018**.
3. Party No.2 agrees to make its Hospital and Practical teaching of the Students and treatment of patients of Party No.1 at a mutually convenient predetermined date and time.
4. Party No.1 solemnly assures that its Undergraduate and Postgraduate students will follow the code of conduct applicable to the students of Party No.1 while they are in the premises of the Hospital (Party No. 2).

5. Party No.1 to make a provision for its Students to participate in the Hospital (Party No. 2) as mutually decided upon.
6. This MoU does not create any permanent rights of Students and Staff member of either of the Institutions in each other's premises.

It is expected that mutual good will and respect will carry the arrangements through.

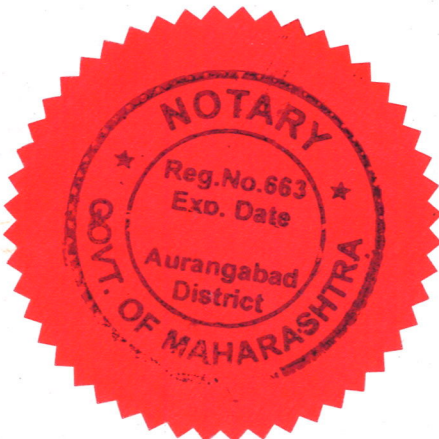


