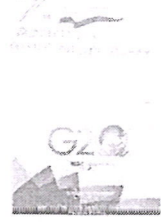

Sir,

Shri Bhagwan Homoeopathic Medical College, and Indira Gandhi Memorial Hospital is functional since 1986 and has submitted an application for permission for sanction of 100 seats in BHMS course for the academic year 23-24. The College has submitted the Part I information in which the entire functional profile has been narrated. MARB has examined the profile of the College as to whether the college fulfils the Minimum Standard Requirement to be fulfilled as per the prevailing regulations under NCH Act 2020 and conducted the Inspection of college on 26.08.2023. Accordingly, it is to inform you that inspection reports submitted by inspectors, were examined by the Medical Assessment and Rating Board and following deficiencies were noticed:

1. All the documentation in IPD and OPD, needs computerization.
2. IPD and OPD records need improvement as some case sheets are lacking in reportorial charts.

College is required to follow standard guidelines in the functionality as under:

- a) Case records should be well maintained in respect of case analysis, evaluation and repertorization and made available in Medical Record Room for academic purpose of students and follow up attendance of patients.
- b) Case sheets should have complete demographic details and contact details of patients.
- c) Diagnosis should be written in ICD 11 criteria


Therefore, Medical Assessment and Rating Board for Homoeopathy has decided to issue permission to Shri Bhagwan Homoeopathic Medical College, and Indira Gandhi Memorial Hospital, Dr. Y.S.Khedkar Marg, N-6, CIDCO, Aurangabad-431003, Maharashtra, with student intake of 100 seats in UG (BHMS) course for the academic year 2023-24. The shortfalls

observed in your College shall be rectified within a period of 15 days and compliance report shall be submitted to the MARBH.

All admissions shall be made from NEET qualified candidates only. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board for Homoeopathy and the penalty as decided will be imposed in such cases. It is further informed that minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India Quota. Counseling for seats under all India quota shall be conducted by respective Counseling Authority of State/ UT govt as designated by Central Government and counseling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the central govt for All India quota or the student admitted thereunder.


The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by Medical Assessment and Rating Board.
